

Your data

I don't log data. I don't track usage. I don't use trackers of any kind. I use session, non-persistent cookies to ensure your experience of my site is a good one. For the mailing list, I use a third-party service called Mailchimp. By subscribing to The TaxPoodle (taxpoodle.net), you acknowledge that your email address will be transferred to Mailchimp for processing; I will not otherwise sell, rent, lease, or share the information you have provided with any other party. What are cookies?

Cookies are very useful and enable a website to recognize you, provide a secure connection, and enhance your user experience by formatting content for your device's characteristics and capabilities; they are messages from the web server ("host") passed to your browser when you visit this site – in other words, cookies are small text files of information that are created when visiting taxpoodle.net and stored on your device by a web browser. A cookie may be sent back to the server whenever your browser requests a page.

How are cookies used?

I use cookies solely to facilitate the performance and functionality of this site, and only for the duration of your visit.

Are there different types of cookies?

Yes. The different types of cookies include session cookies, which are temporary and deleted when the browser is closed; persistent cookies, which remain on the device for a set period of time; first-party cookies, created by the website being visited; and third-party cookies, set by external websites for tracking purposes. If you want to restrict or block the cookies that are set by this website, you can do so through your browser settings. You can visit internetcookies.com, which contains instructions on how to do this on a wide variety of browsers and devices. There you will also find useful information about cookies and details on how to delete them from your device.

What about embedded content from other websites?
